Matter: Information about Different Aspects of Health from the Population of Puerto Rico for the Year 2014

GENERAL INSTRUCTIONS

The Mothers, Children and Teens Division of the Health Department of Puerto Rico are compiling information about different aspects of the health of women of reproductive age. For this purpose, the Health Department of Puerto Rico has requested the collaboration of this Office to obtain that statistic information from the entities dedicated to the health insurance authorized in Puerto Rico.

In harmony with the above, we request to be provided with the following information in these forms:

1. Form - 1 - Number of children between ages 0 to 19 years who were beneficiaries of any health insurance in Puerto Rico for 2014,
2. Form - 2 - Number of women between 10 to 49 years, beneficiaries of health insurance in Puerto Rico for 2014,
3. Form - 3 - Number of children between ages 8 and 9 years who were beneficiaries of any dental cover in health insurance in Puerto Rico for 2014,
4. Form - 4 - Number of children of 8 to 9 years in protective sealants that received at least one permanent molar tooth (CDT3:D1351) in Puerto Rico for 2014,
5. Form - 5 - Number of cases of Bronchial Asthma (Code ICD 9: 493.0 to 493.99) in children between 0 to 4 years, beneficiaries of a health insurance, that were hospitalized in Puerto Rico for 2014,
6. Form - 6 - Number of cases of Bronchial Asthma (Code ICD9: 493 to 493.99) in children between 0 to 14 years, beneficiaries of a health insurance, who were treated at Emergency Room in Puerto Rico for 2014,

7. Form - 7 - Total number of female sterilization (ICD9: V25.2; CPT: 58600, 58605, 58611, 58615, 58565, 58671) performed in Puerto Rico for 2014,
8. Form - 8 - Total number of male sterilization (CPT: 55250) performed in Puerto Rico for 2014,
9. Form - 9 - Total number of women that were performed the PAP test (CPT: 88141-88143, 88147-88148, 88150, 88152-88155, 88160-88162, 88164-88167, 88172-88175) in Puerto Rico for 2014,
10. Form - 10 - Number of children between 0 to 24 years hospitalized for unintended injury or non-fatal in Puerto Rico according to the codes (ICD 9: 800-999) in 2014,
11. Form - 11 - Number of children between 0 to 14 years attended at Emergency Room for unintended injury or non-fatal in Puerto Rico according to the codes (ICD 9: 800-999) in 2014,
12. Form - 12 - Number of children between 2 to 4 years beneficiaries of a health insurance with conduct problem (ICD 9: 312.0 al 312.9, 313.0 and 314.0 al 314.9) in Puerto Rico for 2014,
13. Form - 13 - Number of persons of 0 to 49 years beneficiaries of a health insurance with mental disorders (ICD 9: 290 to 319) in Puerto Rico for 2014.
14. Form: 14 - Number of infants born with fetal alcohol syndrome (ICD 9: 760.71) in Puerto Rico for the year 2014
15. Form: 15 - Number of infants born with neonatal abstinence syndrome (ICD 9: 779.5) in Puerto Rico for the year 2014
16. Form: 16 - number of children from 1 to 6 years with decay (ICD 9: 521.00 TO 521.09) in Puerto Rico for the year 2014

Is required to submit to this Office in printed format and email this report. This information must be classified in private group plans, individual, direct pay and public employees. The electronic report must be sent in Excel format to estadisticas.salud@ocs.gobierno.pr. This information must be sent in or before February 17, 2015.
