Subject: ALTA Commitment For Title
Insurance


It has come to our attention that the Commitment For Title Insurance developed by the American Land Title Association and in use by some title insurance companies, provides a maximum duration of three months after the effective date of the policy.

We are hereby informing to all title insurers that, although binders are not subject to the approval of the Commissioner, they must comply with the provisions of all other applicable rules and regulations of the Insurance Code of Puerto Rico.

Therefore, the aforementioned Commitment for Title Insurance must be issued for an initial period of thirty (30) days and renewed for two additional periods of thirty (30) days not to exceed a total of ninety (90) days pursuant to the provisions of Rule XXV of the Regulation of the Insurance Code of Puerto Rico.

Your compliance with the provisions of this Circular Letter is hereby required.
