TO ALL NON-RESIDENT AGENTS

Subject: Renewal of licenses for fiscal year 1999-2000


Sirs:

Section 7.010 of the Insurance Code of Puerto Rico establishes, as a condition to continue to be authorized to solicit or transact any kind of insurance in Puerto Rico, that the persons or entities so authorized shall pay, not later than June 30th of each year, a single annual contribution.

Considering the above, and in accordance with Section 7.010(1)(q) of the aforesaid Code, the annual contribution to be paid by each non-resident agent shall be \$800.00. To this effect, and in order that said license be renewed as of July 1, 1999, it is necessary that the enclosed form be completed and sent to our Office **before June 5, 1999**, together with a certified check or money order for the aforementioned amount, payable to the Secretary of Treasury, and a pre-addressed small (12" x 9") manila paper envelope.

Please be advised that all requests received after June 30, 1999, will not be considered for renewal by this Office. In said case, the applicant will be subject to all the formalities of the application process for a new license pursuant to the Insurance Code of Puerto Rico.

Strict compliance with the provisions of this circular letter is hereby required.
