**TO ALL DISSABILITY INSURERS AUTHORIZED TO TRANSACT INSURANCE
BUSINESS IN PUERTO RICO**

**Re: Information Regarding the Number of Bronchial Asthma Cases in Children
that Received Hospital, Emergency Room, and Medical Services in Puerto
Rico as of December 31, 2001**

Ladies and Gentleman:

As required by the Federal Department of Health and the Health Department of Puerto Rico, this Office is gathering information regarding the number of bronchial asthma cases (ICD-9 Codes: 493.00 to 493.99), in children between the ages 0 to 14 years, who are beneficiaries of healthcare plan in Puerto Rico (**excluding the Government Health Insurance¹**) and who received hospital, emergency room, and medical services as of December 31, 2001.

To that effect, and pursuant to Section 3.320 of the Insurance Code of Puerto Rico, 26 PR Laws Ann. sec. 332, we have enclosed **Form 1.102 in printed and electronic format (3 1/2" floppy disk)** where you should include the above requested information. Said Form must be filed in this Office by all disability insurers who are authorized to underwrite any kind of healthcare plan, **on or before June 25, 2002**, in the printed and electronic format provided herein.

¹ This refers to the Puerto Rico Health Insurance Administration, Act of 1993, which provide insurance to the eligible beneficiaries according to the Act, commonly known as the "Seguros de Reforma de Salud".

Said information must be filed as follows:


1. Use the diskette provided by this Office;

3. Save the data in the diskette; and
4. Submit both the diskette and Form 1.102 in the same package.

It is extremely important that the electronic filing be submitted to this Office utilizing the enclosed diskette.
