TO ALL AUTOMOBILE CLUBS DOING BUSINESS IN PUERTO RICO

**PREMIUM OR QUOTA TAX RETURN FOR THE CALENDAR YEAR ENDING  
DECEMBER 31, 2004**

Dear Ladies and Gentlemen:


Pursuant to the provisions of Section 21.200 of the Insurance Code of Puerto Rico, each automobile club or association, organized for profit, shall pay on or before March 31 of each year to the Secretary of the Treasury of the Commonwealth of Puerto Rico, through our Office, a tax of one and a half (1.5%) percent on the premiums or quotas received by such club or association during the preceding calendar year.

According to the referred section of law, automobile clubs or associations must pay the corresponding premium or quota tax for calendar year ending December 31, 2004, **on or before March 31, 2005**. For this purpose, we enclose a blank form of the Premium or Quota Tax Return, which should be completed and returned to us, with the corresponding payment, by said date. The payment shall be made by check payable to the Secretary of the Treasury of Puerto Rico.

Automobile clubs or associations which did not write business for the corresponding report period must indicate so in the Premium or Quota Tax Return. Said return must be submitted within the aforesaid deadline.

Strict compliance with the above is hereby required.
