TO ALL DOMESTIC INSURERS, FOREIGN INSURES, AND HEALTH SERVICES ORGANIZATIONS, GENERAL AGENTS AND MANAGERS AUTHORIZED IN PUERTO RICO

**AMENDMENT TO RULING LETTER NUMBER CN-2015-192-ES, DATED DECEMBER 17, 2015, FORM FOR PREMIUM AND COMMISSIONS RELATED TO BUSINESS OF GENERAL AGENTS, MANAGERS, PRODUCERS AND AUTHORIZED REPRESENTATIVES, INDIVIDUALS OR CORPORATIONS**

Dear Sirs and Madams:

This past December 17, 2015 we issued Ruling Letter Number CN-2015-192-ES, to require the issue and delivery of a report with a view to simplifying the process that is required for submitting the Annual Business Report as required in Circular Letter C-ES-3-1727-2005.

To that effect it was required that on or before February 2, 2016 Form OCS-ES-2015-027 be completed and delivered to each of the authorized representatives, producers, managers, and general agents, both corporate and individual, that participated in insurance underwriting transactions during the year covered by the Report.

To address the concerns regarding the date provided in that Ruling Letter, we are hereby changing the deadline for delivering the report to the appropriate parties from February 2, 2016 to February 29, 2016.

Furthermore and once again to address concerns that have been brought to our attention, we have developed the following matrix that will facilitate the identification of the kinds of insurance shown on form OCS-ES-2015-027:
