NOTES TO FINANCIAL STATEMENTS

Note 1 - Basis of Presentation

The accompanying financial statements of **Newport Bonding & Surety Co., Inc.** (also referred to as Newport or The Company) were prepared in conformity with the accounting practices prescribed or permitted by the National Association of Insurance Commissioners (NAIC), except for treatment of recoverable income tax which according to the Insurance Code of the Commonwealth of Puerto Rico, should be recorded as a period expense.

Note 2 - Basis of Valuation of Invested Assets

A. Investment securities at December 31, 2016 consist of Obligations of the Commonwealth of Puerto Rico.

B. Equity securities are recorded at fair value. Debt securities are recorded at amortized cost, adjusted for the amortization or accretion of premiums or discounts (if any). Realized gains and losses on securities are included in earnings. Unrealized holdings gains and losses, net of the related tax effect, on equity securities are excluded from earnings and are reported as a separate component of surplus until realized.

A decline below cost in the market value of any security deemed permanent is charged to earnings, resulting in a new cost basis for the security.

C. As of December 31 2016, the company has a note payable with a brokerage house company for \$211,311 collateralized by certain investments. Unrealized losses on investments in equity securities were caused primarily by downturns in the above mentioned sectors. Newport has evaluated the near-term prospects of the issuers in relation to the severity and duration of the impairment. Based on the evaluation, and the Company's intent and ability to hold these investments for a reasonable period of time sufficient to forecast recovery of fair value, Newport does not consider these investments to be other than temporarily-impaired at December 31, 2016.

D. The Company has no subsidiaries.

E. The market values were obtained from brokerage house companies.

Note 3 - Federal Income Tax Allocation

A. Newport does not file a consolidated federal income tax return.

B. The Company is not subject to federal income taxes, and Puerto Rico tax law does not permit carryback. The company has an excess of income taxes paid of approximately \$19,300 plus an unused tax credit of approximately \$11,898 to be used to offset future tax liability.

Note 4 - Information Concerning Parent, Subsidiaries and Affiliates

A. Newport is not directly or indirectly owned or controlled by any other company, corporation, group of companies, partnership or individual.

B. The Company has no transactions with any affiliate.

C. The Company has no investments on parent, subsidiaries or affiliates.

D. The Company does not own shares of an upstream intermediate or ultimate parent, either directly or indirectly via a downstream subsidiary, controlled or affiliated company.

E. The Company has no undisclosed guarantees or undertakings for the benefit of an affiliate.

NOTES TO FINANCIAL STATEMENTS

F. The Company does not provide to a parent company actuarial or investment services.

Note 5 - Transactions with Related Parties

Newport is related to another company through common ownership and management. The related company is engaged in the management of construction projects that the Company assumed because these were in default.

The Company leases its office facilities from one of its officers on a month-to-month basis. Rent charged was \$36,000 as of December 31, 2016 and \$36,000 in 2015. In addition, one of the stockholders is a counselor in a law firm which provides legal services to the Company. Legal fees charged by this law firm were \$21,000 in 2015.

The Company made advances to officers which are non-interest bearing and have no definite due date.

Due to officers at December 31, 2016 was \$367,800 and at December 31, 2015 was \$344,575.

Note 6 - Retirement Plans, Deferred Compensation, and Other Postretirement Benefit Plans

A. Newport does not sponsor an employee retirement plan.

B. The Company has no deferred compensation plan.

C. The Company has no deferred and other compensation or benefit plans.

Note 7 - Capital and Surplus and Shareholders' and Policyholders' Dividend Restrictions

A. Authorized dividends are limited by the unassigned surplus amount.

B. Newport has no preferred stocks issued and outstanding.

C. The unassigned surplus funds have no restrictions.

D. There is no debenture or similar obligations.

F. There is no dividend's restriction.

Note 8 - Contingent Liabilities

A. Newport has committed no reserves to cover any contingent liabilities.

B. The Company has no pending legal proceedings, except for normal cases or claims in this industry.

Note 9 - Contingencies | Legal Proceedings

Newport is subject to litigation and claims in the ordinary course of business. These lawsuits principally involve claims on policies and are typical for the Company and for the insurance industry in general. Such legal proceedings are considered in connection with the Company's loss expense reserve.

Note 10 - Unsecured Reinsurance Recoverables

Effective on April 2005, Newport entered in an annual reinsurance agreement (hereinafter referred to as the agreement) through reinsurance company (hereinafter referred to as reinsurers). The agreement

allows the Company to accept a maximum loss exposure risk limit per bond of \$2,000,000, subject to a maximum aggregate limit per contractor of \$4,000,000. Coverage is restricted to contractors, construction bonds and security guards businesses located in Puerto Rico, accepted and written by the Company.

Note 11 - Reinsurance Recoverable in Dispute

Newport has no reinsurance recoverable in dispute.

Note 12 - Reinsurance Assumed and Ceded

- A. Newport has not reinsured any risk to this date.
- B. The Company has no additional or return commission.

Note 13 - Structures Settlements

- A. Newport has no annuities under which the Company is owner and payee.
- B. The Company has no annuities under which the claimants are payees.

Note 14 - Reinsurance

Newport protects itself for excessive losses by reinsuring certain levels of risk in various areas of exposure with reinsurer. The amount recoverable from reinsurer will be estimated in manner consistent with the loss adjustment reserve associated with the reinsured policies.

Under the agreement, the Company has a limit of loss exposure risk of \$200,000 per bond.

The Company should pay a premium at various rates and has to pay the premiums (expense) to reinsurers even if no premiums revenues (subject to contract) are written. The agreement requires a premium payable quarterly in advance. The agreement requires a premium payable quarterly in advance. The Company paid premiums of \$61,958 for the nine months ended December 31, 2016 and \$171,146 for the year ended December 31, 2015.

At the end of the agreement, the Company should report the total gross net applicable premium written to reinsurer. The reinsurer agrees to return to the Company (if no claims made under this agreement) a no claim bonus of 20% in 2014 and 2013 applied to the net accounted premiums (less applicable taxes, if any), paid to the reinsurer. The Company shall elect the time of the no claims bonus payment within twenty four (24) months after the anniversary of the contract by giving reinsurers, in writing within 30 days, notice of the elected date. This agreement is effective for one (1) year, and expired in April 2016, and is renewable annually. During 2016, 2015 and 2014 no claims occurred during the year to the Company that required the use of the reinsurance.

Note 15 - Commutation of Cede Reinsurance

Newport has not commuted any ceded reinsurance.

Note 16 - Retroactive Insurance

There is no retroactive insurance.

Note 17 - Accrued Retrospective Premiums

Newport has no accrued retrospective premiums.

Note 18 - Discounting of Liabilities for Unpaid Losses Adjustment Expenses

Newport has not discounted liabilities for unpaid losses adjustment expenses.

Note 19 - Financial Guaranty Insurance Exposures

Newport has no contract which falls into the financial guaranty insurance exposures definition.

Note 20 - Information Concerning Asset Transfers with Put Options

No assets were sold with put options during the year.

Note 21 - Gain or Loss to the Insurer from Uninsured A & H Plans and the Uninsured Portion of Partially Insured Plans

No such business was written during the year.

Note 22 - Asbestos | Environmental (Mass Tort) Reserves

Newport is not subject to asbestos and/or environmental claims (mass tort).

Note 23 - Direct Premiums Written by General Agents

Newport increased its efforts in construction and commercial sureties business. In connection with this efforts, the Company has an agreement with few general agents to underwrite commercial premiums mostly. Premiums earned from policies subscribed by general agencies amounted to \$681,650 for the year ended December 31, 2016 and \$852,415 for the year ended December 31, 2015. The remaining premiums earned come from criminal bail bonds.

Note 24 - Other Items

Newport elected to use rounding in reporting in the Annual Statement.

Note 25 - Commitments

Newport leases certain assets under capital lease agreements the latest of which expires in 2015 and were paid in full. Principal balance of capital lease agreements was \$2,295 at December 31, 2014.

Note 26 - Capital and Surplus

The Insurance Code of Puerto Rico required a minimum capital of \$750,000 for sureties companies. It also required at least \$375,000 as paid in surplus. In December 2003, law 303 amended some disposition of Chapter 3 of the Insurance Code increasing the capital (common stock) requirement to \$1,500,000.

Stockholders contributed as paid in surplus \$13,650 in 2015.

Note 27 - Long-Term Debt

During December 2013, Newport entered in a loan agreement with a financial institution for \$75,000. The loan shall be repaid in thirty six (36) consecutive monthly installments of \$2,394, including interest. The first of such installments was due and paid on January 5, 2014. The loan matures on December 5, 2016, bears a fixed interest rate of 9.25% and is collateralized by personal guarantees of a stockholder.

NOTES TO FINANCIAL STATEMENTS

During 2016, Newport entered in a loan agreement with a financial institution for \$60,000. The loan shall be repaid in thirty six (36) consecutive monthly installments of \$1,950, including interest. The first of such installments was due and paid on March 7, 2016. The loan matures on February 6, 2019, bears a fixed interest rate of 9.25% and is collateralized by personal guarantees of a stockholder.

Note 28 - Subsequent Events

In March 30, 2014, the Office of the Commissioner of Insurance of the Commonwealth of Puerto Rico amends the Article 6.030 of the Insurance Code, who regulates investment eligibility. The new amendment permits that companies whose investments became after acquisition, an ineligible investment under the Code requirements, to dispose of them in a period of three years since the moment the investments become ineligible. A significant portion of Newport's investments were downgraded and then are subject to this law.

During 2016, the Company continued paying its note payable with a brokerage house. Balance at December 31, 2016 was approximately \$211,311.

Subsequent events were evaluated by management through December 31, 2016.
